1. **PAYMENT TERMS:** Popalicious requires a £50.00 booking fee in order to confirm a booking and on submission of the Booking Form. The balance is due no later than 21 days prior to the date of the event and can be paid by cash, cheque or electronic transfer (please request details). **All cheques should be made payable to Alan & Rita Parsons.** There will be a £35 fee charged for all returned cheques.
2. **CANCELLATION:** This agreement cannot be cancelled, except in writing, by either the Client or Popalicious. If the Client initiates the cancellation, Popalicious will hold the £50.00 booking fee. Client will hold harmless Popalicious in the event of illness, injury, act of God, or any other situation beyond control of Popalicious that prevents Popalicious from working. Cancellation fees will apply.
3. **PROVISIONS:** Popalicious requires access to the desired set-up area at least 60 minutes prior to the scheduled start time. In addition, 60 minutes are required after the conclusion of the service period for take down and removal. The Client is responsible for ensuring that there is at least one 240 volt power supply within ten metres of the desired set-up area that adheres to contemporary safety standards and supplies at least 13 amps. Once the Hire has been set-up in the required location, it cannot be moved during the event. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions.
